CATEGORIES:

A. Oil / Acrylics B. Watercolor / Acrylics C. Pastel / Pencil / Pen-ink / Drawing / Charcoal D. Abstract / Experimental / Collage / Mixed / 2 & 3 Dimensional Abstract E. Photography F. Sculpture / Fine Jewelry G. Pottery / Porcelain H. Copies (must include a photo or picture of the original artwork and may be considered for sale if the original artist has **been proven** deceased for 70 or more years. Such works **will not** be eligible for the LSAG convention).

ALL ENTRIES MUST BE THE ARTISTS' ORIGINAL WORK - completed within the past 2 years and in compliance with all LSAG rules. LSAG Rules are listed in the WAL Membership Directory and are available on the LSAG website: www.lonestarartguild.org/LSAG_ShowStructure.html

PRESENTATION: Work to be hung **must** be suitably FRAMED, WIRED, and (if needed), PROTECTED BY CLEAR PLASTIC. (Glass can be used for works smaller than 480 square inches). Saw-tooth hangers and wet work are not acceptable. Free-standing works and sculptures are to be placed on display by the artist. Entrants of unusually large pieces should provide their own easels. Woodlands Art League reserves the right to hang or not to hang pieces due to space limitations. Woodlands Art League retains the right to refuse acceptance of any work deemed not suitable or qualified for display or public viewing by a majority vote of the WAL Board of Directors present when receiving the work for the exhibition.

SIZE and NUMBER of PIECES: Any individual artist may enter up to **6** pieces/items for judging. A triptych is considered 3 pieces for entry purposes, but judged as one.

ENTRY FEES: WAL Members: \$6/entry. LSAG Members: \$8/entry. Non-members: \$10/entry.

School & College Students: \$3/entry. **Please make checks payable to: WOODLANDS ART LEAGUE (or WAL)**

SALES: WAL will accept but not require donations of 10% based on the sale of artwork.

*If you are unable to collect your works on the scheduled date, PLEASE make arrangements with the Show Chairman. See "Agreement and Waiver" on your Artist Registration and Entry Form in regard to unclaimed work. WAL assumes no responsibility for any items stored, including but not limited to damage, theft, or loss.
